A MESSAGE FROM KATE

Kaya!

I hope you enjoyed a wonderful Easter break and the beautiful weather we've been having.

I announced in March that I will run again at the next Federal election. I want to thank everyone who has helped me to do politics differently so far in this term – whether you have helped inform my policy positions, attended events, contributed to one of our community submissions or discussed issues with your friends and family.

The election is still a way off, so for now I'm focused on doing the job you elected me to do as the Independent Member for Curtin. I'm meeting with members of the government and opposition, as well as the crossbench, to drive long-term thinking in our national conversations. improve legislation as it's introduced to Parliament and ensure your voice is heard in Canberra.

It has been a busy couple of months with the launch of Curtin's Pathway to Net Zero report, speaking to UWA students at O-Day, hosting a Menopause Forum, meeting with my new 2024 Youth Advisory Group, and holding our monthly Community Catch Ups and Canberra Debriefs. We also had five Parliamentary sitting weeks across February and March.

One of my key concerns since being elected is the declining trust people have in our politicians and political system.

To rebuild trust, people need to be confident decisions are made in the public interest, not in the interest of a few. The rules about our elections have a big impact on this confidence. This is why I have recently been working on electoral reform with the crossbench in both the House of Representatives and the Senate.

Cost of living remains a big issue on the agenda too. With the steep rise in grocery prices, there has been a lot of discussion about supermarket power. There's no doubt we have an issue in Australia with market concentration in a number of industries. I will continue to advocate for sensible long-term reform that maintains healthy competition.

Over the coming months, I look forward to having more conversations across the electorate about what matters to you, whether it's out doorknocking, at an event or via email. Please complete my cost of living survey (below) and my survey on current issues (on page 2) so I can hear what you think.

CANBERRA UPDATE

Fair & Transparent Elections Bill

In March, as part of my ongoing committment to restoring trust in politics, I introduced my Fair and Transparent Elections Bill. The crossbenches of both Houses support my Bill, including David Pocock in the Senate. The Bill introduces a suite of electoral reforms to rebuild trust in our political system, including voters knowing who is supporting political candidates before they vote. The table shows what the Bill covers.

These changes have broad support. The government says it supports many of them, but I (and many on the crossbench) are concerned that we will not see any change before the next election.

I will keep driving for reform during this term, because shining a light on vested interests will encourage politicians to make decisions in the interests of community, on so many important issues.

SNAPSHOT OF FAIR & TRANSPARENT ELECTIONS BILL

ISSUE

Dark money

We need to fix disclosure requirements and ban lies so voters can make an informed choice about their representatives.

SOLUTION

Lower disclosure threshold to \$1,000

Disclose within 7 days

Fix 'gift' definition to include 'cash for access' dinners, 'business forum' memberships, subscriptions

Require disclosure of fundraising events, investments, memberships,

Ban lies in political advertising

Financial influence

We need to reduce financial influence so we can trust Governments to make decisions for all, not vested interests.

Ban donations from social harm industries

Ban donations from current/ potential substantial government contractors

Ban anyone from donating more than 2% of public funding from the last election (~\$1.5m)

Uneven playing field

We need to reduce some of the many incumbency and party advantages.

Limit self-congratulatory government ads before elections

Stop postal voting applications from being used for data harvesting and misleading voters

Provide equal access to voters & reporting through the creation of an Independent Campaign Entity

IN PARLIAMENT

Voluntary Assisted Dying

In February, I introduced a Private Members Bill to amend the Commonwealth Criminal Code to clarify that Voluntary Assisted Dying (VAD) is not suicide, so medical practitioners can use telehealth to deliver end of life care. VAD is legal in every state but the anomaly in the Commonwealth Criminal Code robs people of that choice if they live too far away. I have been in discussions with many State Attorneys-General who would like to see this anomaly addressed. The Federal Attorney-General is now considering the Bill.

Speed of decarbonisation

In March I presented a Private Members Motion about the barriers to faster decarbonisation and the need to provide production tax

credits for the critical minerals industry. One of the dangers of re-opening the nuclear debate is that it threatens the policy certainty needed by the private sector to invest in renewables, where we have great comparative advantages. With the US Inflation Reduction Act pulling a lot of capital investment to the US, we need a bold government response that makes Australia an attractive investment location for projects that will outlive fossil fuels.

Fuel Efficiency standards update

I support the Government's fuel efficiency standards – we are the only developed country other than Russia that doesn't have these! Requiring car manufacturers to meet an average fuel efficiency level will mean that Australians have access to more fuel-efficient petrol cars, as well as more EVs.

Online Gambling update

The clock is ticking on gambling reform. It has been interesting to see that even some of the gambling companies recognise that reform is needed. I hope that by the time you are reading this newsletter, we will have seen some action from the government on a gambling ads ban.

IN CURTIN

Curtin's Pathway to Net Zero Launch



It was uncomfortable but fitting that we introduced our Net Zero report on one of the hottest days of the summer at Mounts Bay Sailing Club. Environmental scientist Josh Byrne, who you may know from Gardening Australia, braved the heat to attend the launch with nearly 200 other people. The report is the product of a year's work from more than 50 dedicated Curtin volunteers, led by Claire Gardner from my office. It sets out what we can do to decarbonise across electricity, buildings, transport, greening and waste - with policy asks at a Federal, State and Local government level and practical individual actions.

As pictured, Claire and I were pleased to present a copy of the Net Zero Report to the Minister for Climate Change and Energy, Chris Bowen, the Minister for the Environment and Water, Tanya Plibersek, the Attorney-General, Mark Dreyfus, and the State Premier, Roger Cook.

My Community Liaison Officers are wonderful... and here to help you.



My community liaison officers, Felicity and Jo, deal with hundreds of inquiries each month from constituents facing challenges in their dealings with NDIS, Centrelink, ATO, Aged Care Services and Immigration. They can help you navigate these challenges, escalate urgent matters on your behalf and support you in progressing issues.

Here are some case study examples:

Centrelink

A constituent applied for the Aged Pension in June last year and was unable to speak with Centrelink to check its progress. In February, we were able to raise a query with Centrelink, who advised extra documents were required. Once submitted, the claim was then approved.

Immigration visas

We assisted a pregnant constituent's partner, who is not Australian, to be granted a visa in time for the baby's birth.

Australian Tax Office

A constituent was alarmed to see an unexplained debt appear in her ATO account. Despite trying to resolve the matter with the ATO, no explanation or solution could be provided. We raised a query with the ATO and the debt was explained and eventually removed.

Final Report of the Aged Care Taskforce

I welcome the final report of the Aged Care Taskforce as the first step in ensuring the aged care system is adequately funded into the future. I was pleased the Task Force did not recommend an aged care levy nor any change to the exemption from means testing the family home when a spouse is still living in it. I will monitor the implementation of the recommendations to ensure increased co-contributions are fair and transparent for constituents.
